1. The **Inland Revenue Department** invites sealed bids manually from eligible bidders for the procurement of **Supply, delivery and installation of Precision A/C, UPS with batteries and other equipment in DC** under National Competitive Bidding procedures. Bidding is open to all eligible bidders.
2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal.**
3. Hardcopy of the Bidding documents may be purchased from the office of **Inland Revenue Department, lazimpat** by eligible bidders on the submission of a written application, along with the copy of *company/firm registration certificate, tax clearance of fiscal year 2069/70* and upon payment of a non-refundable fee of **NRs. 1,000.00** during office hours on or before 18<sup>th</sup> September 2014.
4. A pre-bid meeting shall be held on Inland Revenue Department at 14:00 hours on 9<sup>th</sup> Sept.2014
5. Sealed bids must be submitted to the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal** on or before 19<sup>th</sup> September 2014 *at 12:00 noon*. Documents received after this deadline shall not be accepted.
6. The sealed bids shall be opened in the presence of bidders' representatives who choose to attend on 19<sup>th</sup> September 2014 at 2:00 PM at the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security from "A" class commercial bank, amounting to Nepalese Rupees **151,000.00** (One Lakh fifty one thousand rupees) which shall be valid for minimum 30 days beyond the bid validity period.
7. The Bidders, who choose to deposit the bid security in the form of cash, the cash should be deposited in District Treasury Controller Office Payment Center no. 3, Deposit Account No.: 1100203, Office Code No : 27-305-03 at Rastriya Banijaya Bank, Thamel Branch and submit the receipt of the deposited amount of cash along with the bid.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. The **Inland Revenue Department** reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever
