- 1. The *Inland Revenue Department* invites *electronic* bids from eligible bidders for the procurement of *the Supply and Delivery of Printing Related Goods* under National competitive bidding Single Stage Two Envelope procedures.
- 2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

- 4. A complete *set* of Bidding Documents may be purchased from the office of *PPMO*, *www.bolpatra.gov.np* and the office by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs *3000* till *27-08-2024*² during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. - 6. Sealed or electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on 28-08-2024. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1PM, 28-08-2024 at the office of Inland Revenue Department. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1,15,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
