- 6. The e-Submitted bids shall be opened in the presence of bidders' representatives who choose to attend on Chaitra 17, 2077 at 14:00 Hours at the office of Inland Revenue Department, Lazimpat, Kathmandu, Nepal.

The Bidders, who choose to deposit the bid security in the form of cash, the cash should be deposited in District Treasury Controller Office, Lazimpat, Kathmandu Deposit Account No.: 1100203000000, Office Code No: 305043501, at Rastriya Banijaya Bank, Thamel Branch and submit the receipt of the deposited amount of cash along with the bid.
