1. **Inland Revenue Department** invites sealed bids from eligible bidders for the procurement of Internet and Intranet service under National Competitive bidding procedures mentioned below. Bidding is open to all eligible bidders.

2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal**.
3. Hardcopy of the Bidding documents may be purchased from the office of **Inland Revenue Department, Lazimpat** by eligible bidders on the submission of a written application, along with the copy of *company/firm registration certificate, NSP/ ISP license, balance sheet with Profit & loss account of last three fiscal year, tax clearance of fiscal year 2073/74* and upon payment of a non-refundable fee of NRs. 3,000.00 for package I and Rs 1000 for package II during office hours on or before Kartik 25, 2075.
4. A pre-bid meeting shall be held on Inland Revenue Department at 14:00 hours on Kartik 15, 2075.
5. Sealed bids must be submitted to the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal** on or before Kartik 26, 2075 at 12:00 noon. Documents received after this deadline shall not be accepted.
6. The sealed bids shall be opened in the presence of bidders' representatives who choose to attend on Kartik 26, 2075 at 14:00 PM at the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security from "A" class commercial bank for package I amounting to Nepalese Rupees 108000. (One lakh eight thousand rupees only) and for package II amounting to NRs 42500.00 (Forty two thousand five hundred only) which shall be **valid for minimum 30 days** beyond the bid validity period.
7. The Bidders, who choose to deposit the bid security in the form of cash, the cash should be deposited in District Treasury Controller Office, Payment Center no. 3, Deposit Account No.: **1100203000000, Office Code No : 305023502** at Rastriya Banijaya Bank, Thamel Branch and submit the receipt of the deposited amount of cash along with the bid
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. **Inland Revenue Department** reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever
